Subject: cdma2000 Access Technology Requirements for M2M

TIA TR-45 would like to make the following cdma2000 transport documents relative to M2M available to oneM2M as information for consideration and not for potential transfer. These TIA published standards and reports are available free of charge by following the instructions attached.

- TSB-474, ‘M2M Study’ (February 2011)
- TIA-4962, “cdma2000 M2M Numbering Recommendations Systems Requirements Document” (March 2012)
- TIA-4954, “Machine-to-Machine (M2M) Communication System Requirements Document” (August 2012)

Based upon the requirements documents listed above, work is ongoing to develop and publish Stage 2 and Stage 3 standards by end-of-year 2012 and beyond.

During the oneM2M development of application layer specifications, we request that oneM2M take into consideration the cdma2000 transport requirements for M2M such that the cdma2000 access technologies can continue to support M2M devices and their applications.
